Enrolment **Process**

01 Orientation

Applicants are welcome to contact the school for an orientation meeting. Appointments can be scheduled in advance on Wednesdays by calling the reception desk during school working hours, Sunday through Thursday, from 9 am to 2 pm. Our contact info can be found on the last page of this document.

02 **Step 1:**

Complete the application form online:

and upon receiving an email you will be requested to visit our campus to submit the required documents.

03 **Step 2:**

After submitting all required documents, an appointment for assessment and family interview will be scheduled. Both parents are required to attend the family interview. Students assessments are conducted by certified teachers. You will be communicated by our student affairs department with the outcome of the assessment within one week.

04 **Step 3:**

Acceptance of the student is subject to the results of the admission process. Upon acceptance a deadline will be announced for submitting the enrolment payment fees (one-time payment). If payments are not secured within this period, the school will not guarantee the available place. Parents will also be informed of any pending paperwork requirements.

05 **Step 4:**

School fees will be paid according to the payment schedule specified hereunder.

Uniform	School uniform is obligatory for all students, it is available in our store (located in campus) and on our online store (visit our website: svs.edu.eg and check it out)
Exams and technology	<ul style="list-style-type: none">• External examinations are excluded and to be announced in due time.• All educational levels, starting CE2 will be required to use iPads as part of the educational program.
Students' life activities	The school trips, camps, after-school activities, and excursions are all excluded, and to be announced in due time.

Discounts

Type	Percentage rate
Family Discounts	In case of a sibling joining the school, the following discounts apply: <ul style="list-style-type: none">• 10% off the basic tuition fees for the 2nd child• 5% off the basic tuition fees for the 3rd child
Full fees payment discount	A 5% discount will be applied on the tuition fees, in case of yearly full fees payment in advance, when payment is conducted before August 15 th , 2025.
Smart Village employees discount	A 5% discount will be applied on the tuition fees, for Smart Village employees, upon showing an HR letter every year.

Terms and conditions

- The onus rests on the parents to ensure fees are settled in a timely manner and is not reliant on the school sending reminders.
- The school reserves the right to hold students' diploma, reports, stamped documents, transcripts and/or transfer certificates until all the school accounts are settled.
- Any given discounts will be removed if payments are not settled by the above due dates.
- It is crucially important for parents to ensure that all their contact information is updated in the school records to avoid missing any of our e-mails and/or SMS.
- It is essential for parents to keep the deposit slip in a safe place and present it to the school whenever requested as proof of payment.
- In case of bank transfers, please make sure that all bank charges are paid from the sender's account and not deducted from the transferred amount.

Refund Policy

- The refund of basic tuition fees is in accordance with the Ministry of Education regulations
- All withdrawal/refund requests must be submitted at the Student Affairs Department by sending an email to vstudentaffairs@svs.edu.eg. All calculations of the refunded amounts will be based upon the date of the withdrawal request sent via email.
- This policy is subject to change to comply with the Egyptian Ministry of Education regulations and Board of Trustees decisions. Should this policy change, it will be announced to the parents.
- The table below shows the percentages of the refunded fees/due to the school that must be settled to proceed with the financial clearance of the student:

If the withdrawal notice is presented before the 1st day of the academic year 2026/2027	The following amounts will be refunded: <ul style="list-style-type: none"> • 90% of the enrollment fees • 90% of the full tuition fees • 100% of the academic resources and accreditation fees • 100% of the paid activity fees
If the withdrawal notice is presented after the 1st day of the academic year 2026/2027	The following amounts will be refunded: <ul style="list-style-type: none"> • 50% of the full tuition fees • 100% of the paid activity fees
If the withdrawal notice is presented after the 1st of November, 2026	The following amounts will be refunded: <ul style="list-style-type: none"> • 50% of the full tuition fees • 50% of the activity fees
If the withdrawal notice is presented after the 1st of January, 2027	No money will be refunded

Late Entry Policy

- Students enrolled during the months of September, October, November, and December will be liable for the full tuition, academic resources, accreditation fees and activity fees
- Students enrolled after that will be subject to the following:

Starting January 1 st until March 31 st , 2027	25% discount is to be applied on tuition
Starting April 1 st until the end of the academic year	40% discount is to be applied on tuition

- Academic resources, accreditation fees, and activity fees must always be paid in full.
- Late enrolment is always subject to the approval of the Ministry of Education and the school's registration policies.
- All due fees must be paid before the student's first day of entry.
